- The rounds can be shared with guests, a delegated member must be present.
 - Any rounds remaining at the end of the season will not be transferable, they must be used in 2026. 4-day members will be able to use their games to participate in certain specific events taking place on weekends (at an additional cost): opening tournament, Saint-Jean Baptiste, Interclub qualification, club championship and Ryder Cup (end-of-season tournament).
 - The minimum consumption fee of 400\$ p.p. (plus taxes and service) must be spent between the opening date of the season and the 2026 Ryder Cup (end-of-season tournament). The unspent balance will be billed to the account (plus taxes) on October 1st and is payable upon receipt. Only purchases in restaurants, halfway house and banquet halls are included in the minimum consumption amount. Other purchases such as at the proshop are not included in this amount.
 - A detailed account statement is sent by email on the last day of the month and is payable no later than the 10th of the following month in a single payment (cash, debit, credit or bank transfer).
 - A credit card payment authorization form must be completed at the start of the season and will be used in the event of non-payment of your account statement.
 - A 5% fee is charged for any account in late payment and privileges including green fees may be suspended without notice.
 - Each delegate must present their club membership card to make charges to the master account.
 - Le Versant reserves the privilege of closing all of its courses for a maximum of 12 days during the season.

CONDITIONS

- **Rounds and carts**
- The member benefits from the privilege of reserving departures up to 14 days in advance (visitors 10 days).
- 4-day members will be able to use their games to participate in certain specific events taking place on weekends (at an additional cost): opening tournament, Saint-Jean Baptiste, Interclub qualification, club championship and end-of-season tournament.
- A second game on the same day (replay) is possible at 50% of the current price, upon availability, without reservation.
- Use of a cart must be shared with another person who has paid for half a cart. If a single player wishes to use a golf cart without sharing, he or she has the option of renting the cart in full by paying the full rental cost subject to availability.
- The driver of a cart must be aged 16 and over and have a valid driver's license.
- The lessor/user of a cart is responsible for damage caused to the cart and must pay the cost of repair or replacement in the event of damage.
- The first teetime in the morning must follow a **playing time of at least 4 hours** and stay away from the course

CONDITIONS - FOLLOWING

Teetime change and no-show policy:

- Teetime changes/cancellations must be made no later than 4 p.m. the day before
- You must register the names of your guests no later than 4 p.m. the day before; departures which do not have the names registered will be canceled without notice.
- After 3 occasions of no-show, a green fee will be automatically debited from your account for each person on the reservation.

Restauration

- The minimum consumption fee (plus taxes and service) must be spent between the opening date of the season and the 2026 Ryder Cup (end-of-season tournament).
- The unspent balance will be billed to the account (plus taxes)) on October 1st and is payable upon receipt.
- Only purchases in restaurants, halfway house and banquet halls are included in the minimum consumption amount. Other purchases such as at the proshop are not included in this amount.
- The golf club holds an alcohol license, so it is prohibited to bring alcoholic products from outside onto its property.

Payment terms

- All membership fees (rounds/cart packages and services) are payable in cash, debit or bank transfer. Credit card payments are not accepted.
- A detailed account statement is sent by email on the last day of the month for purchases made to the master account (proshop, restaurant and halfway house). The statement of account is payable no later than the 10th of the following month in a single payment (cash, debit, credit or bank transfer).
- A credit card payment authorization form must be completed at the start of the season and will be used in the event of non-payment of your account statement.
- A 2% fee is charged for any account in late payment and privileges including green fees may be suspended without notice.
- **It is mandatory to present your membership card at all times** to benefit from discounts and/or to put charges on your account. Otherwise, payment must be made immediately on site (cash, debit or credit).

Rain policy

Less than 8 holes/One green fee for 18 holes | 9 to 12 holes/one green fee for 9 holes | 13 holes and more/none
In the event of closure of the courses due to bad weather, no fees will be debited from the account in the event of non-cancellation in advance.

Others

- Le Versant reserves the privilege of closing all courses twelve (12) days in the season for external events.
- Club life style is important at Versant and we want to offer everyone a pleasant environment. No disrespect towards members, customers and employees of the club will be tolerated.
